End-to-end tariff from Turkey, Egypt and India through the port of Novorossiysk to Moscow as part of a container train, valid for non-dangerous goods.

Terms and tariffs for providing end-to-end service:

- Acceptance of general, **non-IMO** cargo is carried out **only** in the **Customs Clear Cargo (Cargo Customs Declaration)** mode.
- The through tariff includes local fees at the port of Novorossiysk.
- Customs clearance is carried out by the client.
- Payment according to the terms of the contract.
- **VAT** is applied in accordance with the Tax Code of the Russian Federation.
- Tariffs are valid according to the dates indicated in parentheses, the date of application of the tariff is equal to the date of departure of vessel from the port of departure (POL ETD).
- Tariffs are valid for goods confirmed for carriage by the rules and regulations of the Russian Railways. To accept a booking with a rail delivery service on the route Novorossiysk - Moscow, you must perform the following actions:
 - 1) The cargo must be secured on the basis of relevant documents regulating railway transportation (Technical conditions for placing and securing goods in wagons and containers, Approved by the Ministry of Transport of the Russian Federation on May 27, 2003 №. CM-943);
 - 2) Photos of container filling and cargo securing must be provided to the specialist/ agents before transportation;
 The necessary details are clarified upon request by a representative of the company's customer service department.

Cargo protection is considered separately *

- 4224 RUB including reduction VAT 20% for 20' container,

- 8723 RUB including reduction VAT 20 % for 40' container

***It is necessary to clarify the list of goods subject to mandatory protection in accordance with the rules of Russian Railways.**

The removal is carried out on the nearest train without binding to the terminal in Moscow.

Subject to the provision of documents confirming the release of cargo within 5 days from the date of unloading of the vessel, storage is not charged.

In case of providing documents confirming the release of cargo after 5 days from the date of unloading of the vessel, storage is charged according to the tariff indicated above, but does not exceed the period of 14 days from the date of unloading of the vessel.
